I was unable to be at the last meeting, but I have studied the three current visualizations, and while the three are heading in the right direction, I prefer the visualization called Map 2. I support the suggestion made at the last meeting to tweak Map 2 by either:

- moving the southern border to be either the Escondido Creek, or potentially Valley Parkway.
- Taking the area between D1 between I -15 15 and Center City Parkway from El Norte South as far as necessary to balance the majority/minority Latinx population.
- Moving back the area between I-15 and Avocado , as you did o, into D2 and the balance into D3
- Adding the area south to Felicita into D3.

I believe that these adjustments wil balance all three districts.

I hope to see how this turns out.
