## **NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN on WEDNESDAY, JUNE 15, 2022 at 5:00 p.m., the Escondido City Council of the City of Escondido will hold a Public Hearing to consider the following item:

## REPORT OF THE CITY'S WATER QUALITY RELATIVE TO PUBLIC HEALTH GOALS

Provisions of the California Health and Safety Code specify that water utilities with more than 10,000 service connections prepare a special report every three years if any of their water quality measurements have exceeded any Public Health Goal (PHG). The law also requires that where a PHG for a constituent has not been established, the water suppliers are to use the Maximum Contaminant Level Goals (MCLGs) adopted by the United States Environmental Protection Agency (USEPA). Only constituents which have a California primary drinking water standard, and for which either a PHG or an MCLG has been set, are to be addressed. As will be reported in the Water Quality Report for calendar year 2021, the City of Escondido's drinking water met or exceeded all state and federal government drinking water standards. Drinking water standards are distinct from PHGs and MCLGs.

The report will be included as part of the agenda for the regularly scheduled City Council meeting on June 15, 2022.
